Report of Trustees

The trustees present their report and accounts for the year ended 31 July 2019

The Trustees have adopted the provisions of the Statement of Recommended Practice (SORP) "Accounting and Reporting by Charities (Revised 2005) in preparing the annual report and financial statements of the Agape Self Sufficiency Ltd.

Objective of the Agape Self Sufficiency as laid down

The Core objects of the Agape Self Sufficiency are:

AIMS

- To prevent or relief poverty or financial hardship specifically but not excluded in Nigeria and Cameroon.
- 2 To assist in the provision of education, training and healthcare projects
- 3 To support individuals to generate a sustainable income and be self sufficient

1 OBJECTIVES

- 1 Provide debt or money management advice
- 2 Establish a micro- credit scheme- a scheme for making small loans to poor borrowers and providing other forms of assistance such as skills training in areas of particular deprivation in a developing country
- 3 Provide grants to local businesses so that they can give jobs to unemployed persons
- 4 Provide grants of money in the form of the provision of facilities such as supply of tools or books or other expenses connected with vocational training or technical skills
- 5 Send essential food supplies, cooking sets, beddings to help people in a state of poverty as a result of emergency
- 6 Help people gain access to safe water and sanitation and contribute to helping the world's poorest people gain access to these basic requirements

HIGHLIGHTS AND DIFFICULTIES

Higlights

- In 2018, raised a total of £11,311.29 excluding volunteer time and expert support
- Supported over **800** refugees with interventions in health, education and trade
- Provided trauma and counselling workshops to 300 refugees
- Funded and supported 100 small scale businesses
- 450 bibles donated for distribution
- In 2019 raised a total of £9,635 excluding volunteer time and expert support
- Sensitized a total of about 3,000 persons for Self-sufficiency Free Medical Outreach Project
- Conducted free medical consultations, eye care, dental services, deworming program, free drugs
- 1335 patients treated, 812 females and 523 males
- 250 mosquito nets and 85 bibles distributed
 Supported 28 internally displaced women prostituting for survival

Report of Trustees

Challenges

- Late release of funds for the project.
- Inadequate funding for the project.
- Mobilization and transportation of Refugees was difficult from far to reach areas.
- Inability to convey sufficient relief materials to project site.
- Long travelling time between Takum and Gembu LGAs.
- Language barrier in communication.
- Several clients declined tooth extraction as a result of misinformation.
- Inadequate laboratory equipment and supplies
- More volunteers required to raise funds to address needs of widows, orphans and traders waiting on our waiting lists.
 - Future Programme activities
- Fund raising to support livelihood projects for 240 refugees and purchase bibles for 1000 waiting for babies.
 - Set up a resource centre in 2020/21 to facilitate the training of refugees in ICT, hairdressing, barbing
 - Fund raising to support more prostitutes to engage in meaningful activities and leave prostitution
 - Increase user involvement in all aspects of the project on a yearly basis

REVIEW OF ACTIVITIES AND FUTURE DEVELOPMENTS

The statement of financial activities is set out on page 7 of the financial statements. A snapshot of the financial results is set out below:

Income Generation

The main source of income generation is from fundraising events, village groups, meeting associations, friendship groups, churches, charitable grant-makers, and whatsapp groups

Investment Policy

At present the Trustees have decided to leave all surplus funds in the account with their principal bankers.

Fundraising Activities

The charity relies solely on contributions from its members and volutary contributions. The charity does not employ any professional fundraising bodies.

Restricted Funds

There are no restricted funds operated by the charity. All funds are available for use at the discretion of the Trustees.

Reserves Policy

The Trustees have decided to spend as much money as possible on furthering the core objects of the charity whilst maintaining sufficient cash funds to ensure the sustainability of the charity.

Review of charity activities

The charity has continued to undertake activities in line with its objectives. in giving to its work.

Governance and Internal Control

Appointment of Trustees are done by the existing Trustees with consultation of the view of the church members as to trustworthiness of each person.

Risk Assessment

The Trustees consider the key operational, financial and stategic risks that may have a bearing on the activies of the charity. Suitable management information is available to the Trustees on a regular basis to monitor these risks and allow any mitigating action to be taken to address them.

Trustees' Responsibilities

Charity law requires the Trustees to prepare financial statements for each financial year which give true and fair view of the state of affairs of the charity and of its financial activities for the year.

In prepararing those financial statements, the Trustees are require to:

- 1 select suitable accounting policies and apply them consistantly;
- 2 make judgements and estimates that are reasonable and prudent;
- 3 state whether applicable accounting standards and stements of recommened practice have been followed, subject to any departures disclosed and explained in the financial statements:
- 4 prepare the financial statements on the going concern basis unless it is inappropriate to assume that the charity will continue in operation.

The Trustees are reponsible for keeping accounting and financial records which disclose with reasonable accuracy at any time the financial position of the charity and to enable them to ensure that the financial statements comploy with the Charities Acts 1993. They are also responsible for safeguading the assests of the charity and hence for taking reasonable steps for the prevention and detection of fruad or other irregularities.

1 ACCOUNTING POLICIES

Basis of accounting

The financial statetements are prepared in accordance with applicable accounting standards using the Historical Cost Convention.

The financial statements reflect the requirements of the revised Statement of Recommended Practice "Accounting for Charities" (SORP). The Agape Self Sufficiency complied with best practice at the time of preparing these accounts.

Tangible Fixed Assets

All fixed assets are capitalised. The charge for depreciation is calculated to write off the cost of the fixed assets over their useful lives on the following bases:

Equipment 20% on the reducing balance Motor Vehicles 25% on the reducing balance

GENERAL

These Accounts have been prepared on the receipts and payments basis and in accordance with applicable Accounting Standards and the Charitable SORP. (Statement of Recommended Practice on Accounting by Charities).

Income

Income is accounted for on accruals basis, except for donations, which are credited when received These represents gifts, donations, pledges, and bank interest given to the Charity during the year.

2 Charitable Donations & Gifts to Missions

These represent amounts given to various individuals, organisations and other charitable trusts. Honorarium to visiting speakers and remittances for missionary work.

Expenditure

All expenditure is accounted for on an accruals basis.

Resources expended on charitable activities comprise all the resources applied by the charity in underkating its work to meet its charitable objectives. These costs include the direct costs of the charitable activities with those support costs incurred that enable these activities to be undertaken.

Expenditure on governance costs are the costs incurred by the charity to operate and to generate the information required for public accountability.

Funds

The charity's funds are unrestricted and are available for use at the discretion of the Board of Trustees.

Board of Trustees Remuneration and expenses

No remuneration directly or indirectly was paid or payable out of the funds to any of the Trustees for their duties as trustees.
